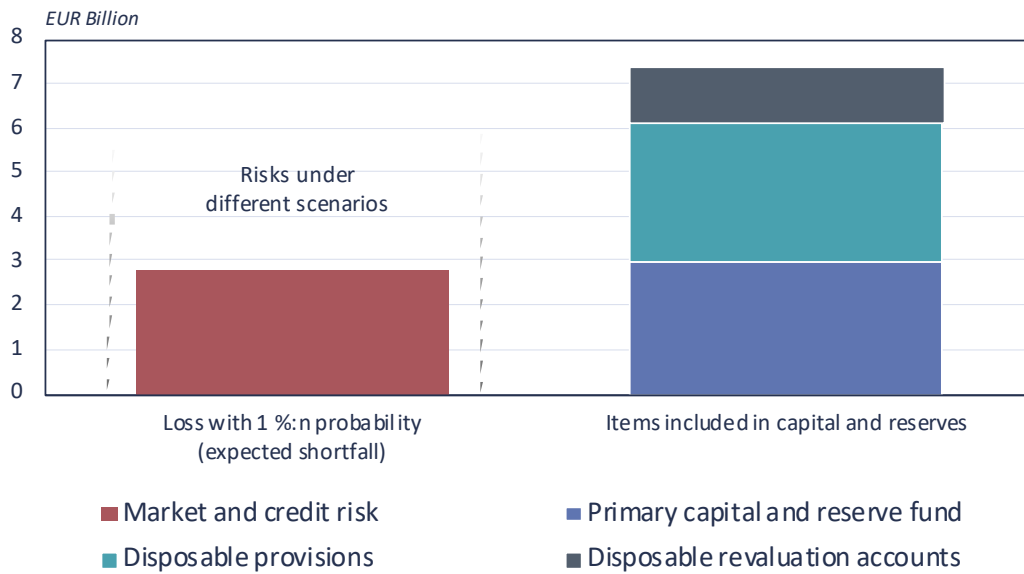


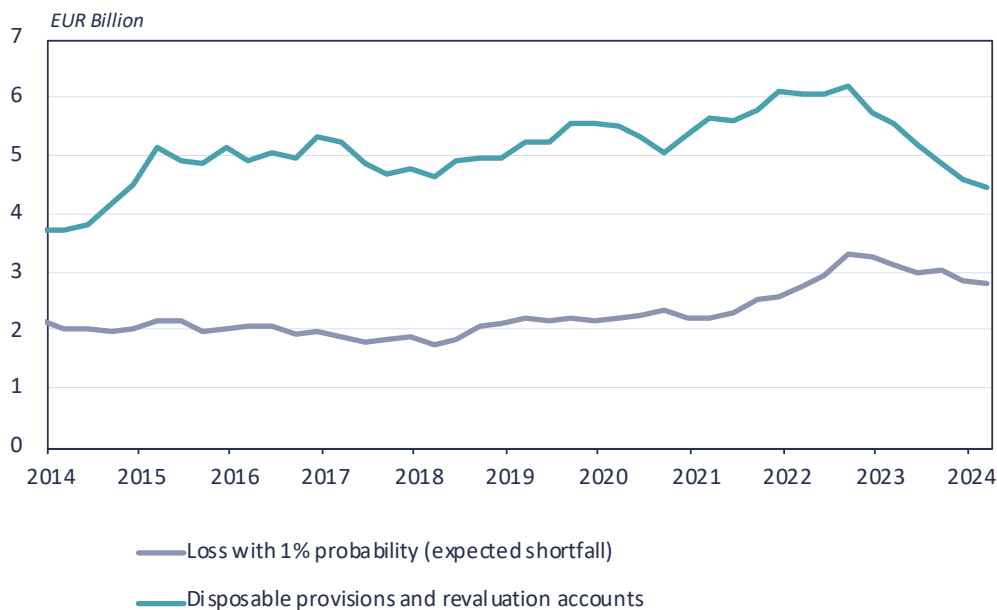

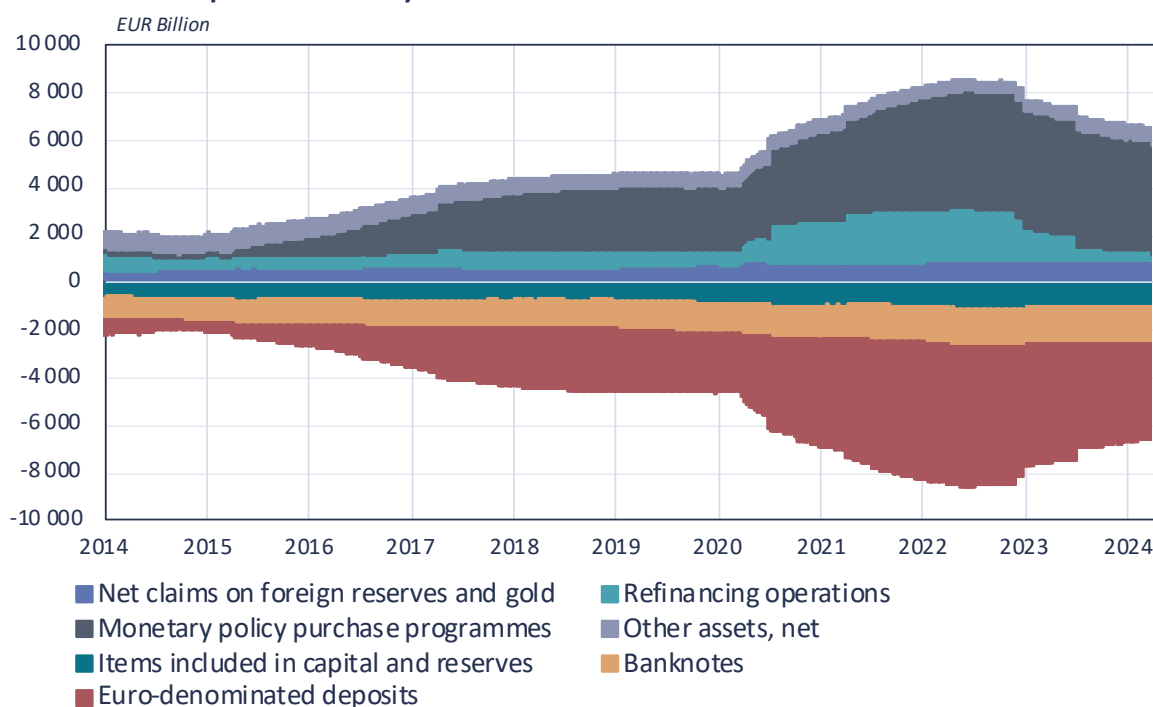
The Bank of Finland's total risk exposure, capital and reserves, excl. gold price risk and gold revaluation accounts
